ARTICULATION TRANSFER AGREEMENT

**Wisconsin Technical College System (WTCS) Nursing -
Associate Degree (ADN)
And
Bachelor of Science in Nursing: RN to BSN Completion Program for Registered Nurses Concordia
University Inc. Baccalaureate Degree**

This agreement applies to students completing an associate's degree at a Wisconsin Technical College System and entering Concordia University Inc. to complete a CU Inc. RN to BSN Completion Program.

Purpose

This school-to-school articulation agreement establishes a formal agreement between all Wisconsin Technical College System institutions and Concordia University Inc. It is based on a review and analysis of the curriculum from the schools in the Wisconsin Technical College System in relation to the Baccalaureate curriculum at Concordia University Inc.

This agreement will facilitate the transfer of credits earned by qualified students of the Wisconsin Technical College System into a Baccalaureate degree program at Concordia University Inc. by guaranteeing the transferability of academic coursework that constitutes part of the successful completion of a Nursing - Associate Degree (ADN) to a Concordia University Inc. Baccalaureate Degree, from a Wisconsin Technical College System Institution.

Terms of the Agreement

- A. Because these transfer agreement provisions are used in transfer agreements with several Technical Colleges, the term "Technical College" will be used to refer to the specific colleges named at the bottom of this transfer agreement and colleges covered listed as CVTC schools.
- B. Students who successfully complete the Nursing - Associate Degree (ADN) at WTCS and who meet admission requirements at Concordia University (CU INC.) can earn a Bachelor's Degree at CU INC.

In particular, any WTCS student who:

- C. Meets the CUW admission requirements for transfer students into the BSN Completion program at CUW with a cumulative GPA of 2.75 or greater for full acceptance, or with a GPA <2.75 for consideration of acceptance on a conditional basis, and
- D. Has successfully passed the NCLEX-RN licensure exam, holds an unencumbered RN license in the U.S., and
- E. Must be employed as an RN throughout the program, and
- F. A minimum of a C is required to transfer in statistics*, nursing courses, and the following science courses: Anatomy & Physiology I and II or an approved equivalent, and Microbiology, student shall then be admitted with junior status into the BSNc program. *Note: Statistics must be taken in the last five years to transfer in.*

- G. An active agreement begins at the commencement of classes. The agreement must be actively reviewed by the program faculty of all CVTC schools and renewed at least every two years to continue the agreement. Reasonable accommodations will be made for students if either program must be changed, but additional courses may be required of students if the program changes. Students must be informed of this possibility "upfront."
- H. This agreement does not guarantee a student's acceptance into CU Inc.'s program.
- I. Each institution is responsible for notifying the other of any changes in the program or curriculum.
- J. The Parties will abide by confidentiality requirements outlined in the Family Education Rights and Privacy Act (20 USC § 1232g ("FERPA") and other applicable laws.
- K. All parties are accredited by the Higher Learning Commission.
- L. For the instruction of the designated transfer courses, the Technical College will use faculty members who meet state approve requirements and will be designated as "approved faculty" members.
- I. The Agreement

All parties agree to provide at least one hundred eighty (180) days advance written notification of their intent to cancel this agreement. Students who apply to CU INC. before the cancellation date will be permitted to transfer credits under the agreement terms. All parties further agree that failure to maintain regional accreditation required by the specific academic program(s) referenced in this agreement will be grounds for exclusion of that program from the agreement.

Wisconsin Technical College System (WTCS): Nursing - Associate Degree (ADN) Concordia University: Nursing

NOTE: Many students have more than the minimum credits from WTCS or another educational institution.

CU INC. accepts up to 84 qualifying transfer credits. All students must have 120 credits to graduate. This plan is subject to change based on the number of qualified transfer credits. Courses are offered in an accelerated; online format; typically, students take one course at a time.

However, to qualify for federal student aid, students must be enrolled at least half-time (or 6 credits) for Direct Loan Program funds.




