The "Letter of Introduction" is intended to confirm dates and times for each Level II placement.

Once approved by your fieldwork lab instructor, the student will email a final copy of these documents to their fieldwork educators one month before their arranged start date. To participate in Level II Fieldwork, these documents must be approved and submitted.
