# NORTHWOOD TECHNICAL COLLEGE HEALTH SCIENCES STUDENT POLICIES

## **AUTOMATIC PROGRAM DISMISSAL**

#### **DENTAL ASSISTANT**

- Students who have been dismissed from the Dental Assistant (DA) program for Code of Conduct violations are not eligible to reenter the Northwood Tech DA program.
- If a student is removed from an office at the dentist's request due to behavior problems, that student receives a failing grade.

### **HEALTH INFORMATION TECHNOLOGY**

- If a student is dismissed for academic dishonesty or other code of conduct issues, they are not eligible to reenter the Health Information Technology (HIT) program.
- Dismissal from a Professional Practice Experience (PPE) site results in program dismissal.

## **MEDICAL ASSISTANT**

- Students who have been dismissed from the Medical Assistant (MA) program for Code of Conduct violations are not eligible to reenter the Northwood Tech MA program.
- If the Clinical Manager/Practicum Coordinator dismisses a student from the clinical site, the student will be dismissed from the MA program, and the dismissal is final with no option for reentry to the MA program.

#### MEDICAL LABORATORY TECHNICIAN

- Students who have been dismissed from the Medical Laboratory Technician (MLT) program for Code of Conduct violations are not eligible to reenter the Northwood Tech MLT program.
- If the Clinical Manager dismisses a student from the clinical site, the student will be dismissed from the MLT program, and the dismissal is final with no option for reentry to the MLT program.

#### **NURSING-ASSOCIATE DEGREE**

- Students who have been dismissed from the Associate Degree-Nursing (ADN) program for Code
  of Conduct violations are not eligible to reenter the Northwood Tech ADN program.
- If the Clinical Manager dismisses a student from the clinical site, the student will be dismissed from the ADN program, and the dismissal is final with no option for reentry to the ADN program.

## **OCCUPATIONAL THERAPY ASSISTANT**

- Students who have been dismissed from the Occupational Therapy Assistant (OTA) program for Code of Conduct violations are not eligible to reenter the Northwood Tech OTA Program.
- Failure of OTA core courses 10514184 (OTA Fieldwork I), 10514186 (OTA Fieldwork IIA), or 10514187 (OTA Fieldwork IIB) results in automatic dismissal from the OTA program, and the dismissal is final with no option for reentry to the OTA program.

### PHARMACY TECHNICIAN

• Students who have been dismissed from the Pharmacy Technician (PhT) program for Code of Conduct violations are not eligible to reenter the Northwood Tech PhT program.

# NORTHWOOD TECHNICAL COLLEGE HEALTH SCIENCES STUDENT POLICIES

## **PHLEBOTOMY**

- Students who have been dismissed from the Phlebotomy program for Code of Conduct violations are not eligible to reenter the Northwood Tech Phlebotomy program.
- If the Clinical Manager dismisses a student from the clinical site, the student will be dismissed from the Phlebotomy program, and the dismissal is final with no option for reentry to the Phlebotomy program.
