The session will also address thermal burns from processing and chemical burns from sanitation, particularly food manufacturing.

Artificial Intelligence and robotics have permeated our workplace! But what is it and how can it be useful? These three 'infomercials' are case studies of AI and robotic applications. Listen how an operational platform that collects, analyzes and processes data to enable the process managers, supervisors, leads, and line operators to quantify inefficiencies. A demo of two versions of the exoskeletons, one for overhead work and one for heavy horizontal work. Exoskeletons are to mimic, augment or enhance the body's own motions. Aspects of Medical Evaluation Under OSHA's Respiratory Protection Standard

Employers are required to provide protection to employees that may be exposed to harmful airborne materials under the OSHA 1910.134 "Respiratory Protection Standard." This session will provide a review of the Standard, discussion of the physical effects on respirator use, and discussion of the components of the medical evaluation process. Included will be a dialogue on tips and techniques to ensure employee conformity with respirator use plus interacting with evaluating medical providers to promote optimum workforce health, safety, and compliance.
