Interview and interrogation techniques will be practiced within legal guidelines of Miranda.

- you describe how to properly label evidence

- you describe the importance of analyzing all the evidence towards corroboration of the victim's statement and the prosecution of the case
- you describe the importance of making inquiries of Probation and Parole, Registered Sex Offender database, the FBI Behavioral Unit or other agencies that may assist in investigation
- you describe the appropriate documentation for sexual assault
