Degree: Associate of Applied Science-Nursing

LPN to ADN STUDENTS

Northwood Tech and the Associate Degree Nursing faculty value the education and experience you have obtained as an LPN from an accredited PN program. Through the LPN to ADN track, we provide a mechanism to obtain advanced standing in the ADN program. The LPN to ADN student will be granted up to 19 of the 37 nursing credits in the ADN program. Additionally, the student may transfer the general studies portion of the program. Students must complete the general studies courses identified below as prerequisites **PRIOR** to being placed on the LPN to ADN waitlist and prior to entry into the nursing courses.

Students may be admitted as "pre-LPN to ADN" to complete the prerequisite courses while also being eligible for Financial Aid. The prerequisites may be completed in 1 to 2 years of part-time study. Core nursing courses may be completed in 1 year. LPN to ADN students join the Northwood Tech ADN program in Semester 3 of the 4-semester ADN program.

LPN to ADN STUDENT DEFINITION-non-Northwood Tech college

You will be considered a LPN to ADN student if you are applying to Northwood Tech after completing an accredited PN program at another college with courses that are transferrable to complete Northwood Tech's first two semesters core (nursing) courses, passing your LPN boards, and holding a current, active LPN license.

LPN to ADN STUDENT DEFINITION-Northwood Tech

You will be considered an LPN Reentry student if you are applying to Northwood Tech after choosing to job out as a PN, out-of-sequence student. You will not need to apply as an LPN to ADN student. Instead, you will follow the Northwood Tech Reentry policy.

REQUIRED ADMISSION PROCESS LPN to ADN students are admitted "as space is available" and only during the fall semester. We do not offer a specific section of classes just for LPN to ADN students. In the event that there is not space available, LPN to ADN students may be placed on a Wait List that is prioritized according to the date of fulfilling all requirements to begin ADN Semester 3 classes. Students who have not completed all required ADN Semester 1 and 2 General Studies requirements are not eligible to be placed on the Wait List.

ADN COURSEWORK

ADN courses are developed so that they are taken in the order listed. The LPN to ADN Curriculum plan listed above indicates all required coursework. Completion of "BLS Basic Life Support" training is a prerequisite to the first nursing clinical course (10- 543-104) and must be maintained throughout the program. All 4th semester courses must be completed at Northwood Tech.

CLASS COMMITMENT

The average amount of time spent in the classroom for a full-time student is between 19 and 23 hours per week. In addition to scheduled class time, it is expected that students spend at least two to three hours studying for each hour of classroom lecture they attend. This represents a significant time commitment, and most students find it necessary to reduce work hours during the program.

TRANSFER CREDIT

Official college transcripts are required for any college coursework that has been completed. Official college transcripts must be sealed and sent from the sending institution or sent electronically through a secure transcript ordering service directly to Northwood Tech for review. The prerequisite courses must be completed with a 2.0 or better prior to admission. The student must have a current, active LPN license, have graduated from an accredited PN program and must successfully complete the LPN Refresher course before admission to the core (nursing) courses.

ADN PROGRAM STANDARDS

ADN students must complete all required courses with a 2.0 or better. ADN students will be dismissed from the program if fail two core (543 nursing) courses. Withdrawal from the same course two (2) times is considered a failure of the course and counts toward the ADN Program Dismissal Policy. This policy includes core (543 nursing) courses taken at other Wisconsin Technical College System colleges and will be considered when determining your eligibility for transfer.

COMPUTER NEEDS

Since all ADN courses include a web-based component, students are required to have computer and internet access.

ACCREDITATION

The Nursing-Associate Degree program at Northwood Technical College is accredited by the <u>Accreditation</u> <u>Commission for Education in Nursing, Inc. (ACEN)</u>, 3390 Peachtree Road NE, Suite 1400, Atlanta, GA 30326, phone 404-975-5000. The most recent accreditation decision made by the ACEN Board of Commissioners for the associate degree nursing program is continuing accreditation.

WISCONSIN BOARD OF NURSING REQUIREMENTS:

Graduates of the ADN program are eligible for the licensure examination if the following requirements are met:

- a. Graduation from high school or its equivalent
- b. Does not have an arrest or conviction record deemed significant
- c. Hold a diploma of graduation from an accredited school of professional nursing
- d. Payment of the requisite fee

BACKGROUND CHECKS

- There is no automatic disqualification from licensure based on a conviction record. The Board has the
 authority to deny licensure to anyone with a conviction record or pending charge, the circumstances of
 which substantially relate to the duties of that person's licensure. In making this determination, the board
 considers the following factors:
 - a. The nature and seriousness of the act for which convicted/arrested (as the circumstances relate to the practice of professional or practical nursing)
 - b. The proximity in time of the conviction/arrest to the present
 - c. The success of rehabilitation (if any has been indicated)
 - d. The record since conviction/arrest
- 2. The Board will not offer an opinion of eligibility for licensure until the graduate applies for licensure. The graduate will need to provide copies of any judgments of conviction and criminal complaints. The Board will investigate and determine whether they substantially relate to the practice of nursing.
- 3. Students in the ADN program will attend practical sessions in clinical agencies that are regulated by state and federal government. The laws state that these clinical agencies may not hire anyone with a history of conviction of certain crimes. Northwood Tech must contract with these clinical agencies to provide your clinical experiences while in the program. In order to do so, the agencies expect Northwood Tech to adhere to the same guidelines in other words, they view students as temporary employees.

Prior to starting core classes, you will be asked about your conviction history and a conviction record will be obtained from a national criminal background check, the Department of Justice and Wisconsin Department of Health Services and, if applicable, from the Minnesota Department of Human Services. Having a conviction history will not necessarily stop you from entering the program. We will need to discuss the charges with you and will make every attempt to confidentially resolve the concern with the clinical agencies utilized for the clinical courses. Ultimately the clinical agencies reserve the right to determine what is an acceptable background check. The clinical agency may deny access to their setting based on a negative background check. If this occurs, you would not be able to complete the ADN program requirements. The costs of background checks are the responsibility of the student.

GRADUATE SALARY EXPECTATIONS

Graduates earn between \$42,117—\$72,794 annually. The most recent graduate follow-up study indicates the average yearly salary to be \$63,150. Graduates can expect to receive shift differential pay.
