Degree: Associate of Applied Science-Nursing

ADN PROGRAM FOR LPN to RN STUDENTS

Northwood Tech and the Associate Degree Nursing faculty value the education and experience you have obtained as an LPN from an accredited PN program. Through the LPN to RN track, we provide a mechanism to obtain advanced standing in the ADN program. The LPN to RN student will be granted up to 19 of the 37 nursing credits in the ADN program. Additionally, the student may transfer the general studies portion of the program. Students must complete the general studies courses identified below as prerequisites **PRIOR** to being placed on the LPN to RN waitlist and prior to entry into the nursing courses.

Students may be admitted as "pre-LPN to RN" to complete the prerequisite courses while also being eligible for Financial Aid. The prerequisites may be completed in 1 to 2 years of part-time study. Core nursing courses may be completed in 1 year. LPN to RN-to-ADN students join the Northwood Tech ADN program in Semester 3 of the 4-semester ADN program.

LPN to RN STUDENT DEFINITION-non-Northwood Tech college

You will be considered an LPN to RN student if you are applying to Northwood Tech after completing an accredited PN program at another college with courses that are transferrable to complete Northwood Tech's first two semesters core (nursing) courses, passing your LPN boards, and holding a current, active LPN license.

LPN to RN STUDENT DEFINITION-Northwood Tech

You will be considered an LPN Reentry student if you are applying to Northwood Tech after choosing to job out as a PN, out-of-sequence student. You will not need to apply as an LPN to RN student. Instead, you will follow the Northwood Tech Reentry policy.

REQUIRED ADMISSION PROCESS LPN to RN students are admitted "as space is available" and only during the fall semester. We do not offer a specific section of classes just for LPN to RN students. In the event that there is not space available, LPN to RN students may be placed on a Wait List that is prioritized according to the date of fulfilling all requirements to begin ADN Semester 3 classes. Students who have not completed all required ADN Semester 1 and 2 General Studies requirements are not eligible to be placed on the Wait List.

ADN COURSEWORK

ADN courses are developed so that they are taken in the order listed. The LPN to RN Curriculum plan listed above indicates all required coursework. Completion of "BLS Basic Life Support" training is a prerequisite to the first nursing clinical course (10- 543-104) and must be maintained throughout the program. All 4th semester courses must be completed at Northwood Tech.

CLASS COMMITMENT

The average amount of time spent in the classroom for a full-time student is between 19 and 23 hours per week. In addition to scheduled class time, it is expected that students spend at least two to three hours studying for each hour of classroom lecture they attend. This represents a significant time commitment, and most students find it necessary to reduce work hours during the program.

TRANSFER CREDIT

Official college transcripts are required for any college coursework that has been completed. Official college transcripts must be sealed and sent from the sending institution or sent electronically through a secure transcript ordering service directly to Northwood Tech for review. The prerequisite courses must be completed with a 2.0 or better prior to admission. The student must have a current, active LPN license, have graduated from an accredited PN program and, must successfully complete the ADN Concepts & Roles course before admission to the core (nursing) courses.

ADN PROGRAM STANDARDS

ADN students must complete all required courses with a 2.0 or better. ADN students will be dismissed from the program if fail two core (543 nursing) courses. Withdrawal from the same course two (2) times is considered a failure of the course and counts toward the ADN Program Dismissal Policy. This policy includes core (543 nursing) courses taken at other Wisconsin Technical College System colleges and will be considered when determining your eligibility for transfer.

COMPUTER NEEDS

Since all ADN courses include a web-based component, students are required to have computer and internet access.

ACCREDITATION

Northwood Tech's nursing program is accredited by the Accreditation Commission for Education in Nursing, Inc. (ACEN) and approved by the Wisconsin State Board of Nursing. WISCONSIN BOARD OF NURSING REQUIREMENTS:

Graduates of the ADN program are eligible for the licensure examination if the following requirements are met:

- a. Graduation from high school or its equivalent
- b. Does not have an arrest or conviction record deemed significant
- c. Hold a diploma of graduation from an accredited school of professional nursing
- d. Payment of the requisite fee

BACKGROUND CHECKS

1. There is no automatic disqualification from licensure based on a conviction record. The Board has the authority to deny licensure to anyone with a conviction record or pending charge, the circumstances of which substantially relate to the duties of that person's licensure. In making this determination, the board considers the following factors:
 - a. The nature and seriousness of the act for which convicted/arrested (as the circumstances relate to the practice of professional or practical nursing)
 - b. The proximity in time of the conviction/arrest to the present
 - c. The success of rehabilitation (if any has been indicated)
 - d. The record since conviction/arrest
2. The Board will not offer an opinion of eligibility for licensure until the graduate applies for licensure. The graduate will need to provide copies of any judgments of conviction and criminal complaints. The Board will investigate and determine whether they substantially relate to the practice of nursing.
3. Students in the ADN program will attend practical sessions in clinical agencies that are regulated by state and federal government. The laws state that these clinical agencies may not hire anyone with a history of conviction of certain crimes. Northwood Tech must contract with these clinical agencies to provide your clinical experiences while in the program. In order to do so, the agencies expect Northwood Tech to adhere to the same guidelines - in other words, they view students as temporary employees.

Prior to starting core classes, you will be asked about your conviction history and a conviction record will be obtained from a national criminal background check, the Department of Justice and Wisconsin [Department of Health Services](#) and, if applicable, from the Minnesota [Department of Human Services](#). Having a conviction history will not necessarily stop you from entering the program. We will need to discuss the charges with you and will make every attempt to confidentially resolve the concern with the clinical agencies utilized for the clinical courses. Ultimately the clinical agencies reserve the right to determine what is an acceptable background check.

The clinical agency may deny access to their setting based on a negative background check. If this occurs, you would not be able to complete the ADN program requirements. The costs of background checks are the responsibility of the student.

GRADUATE SALARY EXPECTATIONS

Graduates earn between \$59,506–\$123,542 annually. The most recent graduate follow-up study indicates the average yearly salary to be \$74,226. Graduates can expect to receive shift differential pay.

LPN to RN Student Checklist for ADN Admission

As space is available in ADN Semester 3, LPN to RN students will be admitted into the core nursing courses. If space is not available, applicants will be placed on the LPN Entrance List. Order of the LPN Entrance List is based on the date and time of completion of all criteria of the application process and the completion of all prerequisite courses.

Submit the following to the Admissions Advisor at the Northwood Tech campus you wish to attend:

- _____ Submit a copy of your current, unrestricted, active LPN license from U.S. State Boards of Nursing. Applicants without a U.S. issued state board of nursing license will need to apply and obtain a license from the state in which you reside.
- _____ Submit an official LPN transcript from a program that was accredited at the time of graduation.
- _____ Submit statement of good standing from the Dean of Nursing or Nursing Program Director at the most recent college attended core (nursing) courses.

Once good standing and transcripts have been reviewed for credit for prior learning and LPN to RN status, you will be notified of your LPN to RN review status. Once you have been notified of your LPN to RN review status, complete the Northwood Tech Application for the LPN to RN program.

- _____ Complete application and submit with fee (fee waiver may apply if previously submitted)
- _____ Successfully complete the required entrance assessment (*Accuplacer Next Gen*) with a score of 263, or provide documentation of prior assessment testing that meets this standard. The college provides support for remediation if necessary.
 - The *Accuplacer Next Gen* test may be waived if:
 - the transfer student has an associate degree or higher
 - or student provides documentation of an ACT composite score of 22 with a minimum math score of 18
 - or the student provides a copy of previous admission information showing that the student was admitted into an ADN program within the Wisconsin Technical College System and was not dismissed from the program

- _____ Have earned a high school diploma or GED/HSED certificate. Current HS seniors must provide both a current high school transcript and a final transcript with confer date.

- _____ Complete one year, or one credit, of HS chemistry or one credit of college-level chemistry with a 2.0 or better.

- _____ Have completed and passed or received credit for prior learning for the following general education classes:

- English Composition 1 or Written Communication
- General Anatomy & Physiology
- Advanced Anatomy & Physiology
- Developmental Psychology
- Oral/Interpersonal Communication or Speech

NOTE: Intro to Sociology, Intro to Psychology, Microbiology, and elective courses are not prerequisite to the LPN to RN path but are strongly recommended for completion prior to entering clinical courses.

- _____ Participate in an admission meeting and educational goal discussion with a Northwood Tech counselor

See prerequisite general studies course requirements below.

Prerequisite general studies courses required *before* entering ADN program as an ADN Semester 3 student—must have a grade of 2.0 or higher. If prerequisite general studies courses are not completed, but other admission requirements are completed, student may be admitted to pre-LPN to RN while taking general studies courses and be Financial Aid eligible. *The documents below should be **uploaded to Student Passport System** and will be reviewed and accepted by the Program Coordinator prior to acceptance to the ADN program:*

- _____ Possess current certification of "BLS Basic Life Support" or the equivalent
- _____ Pass a physical exam, have current immunizations, and demonstrate negative status for tuberculosis (TB). Decision to not receive vaccinations may limit ability to obtain clinical placement based upon meeting site placement requirements.
- _____ Prior to attendance in core Nursing coursework, student must
 - Submit Background Check fee
 - Have an acceptable Wisconsin Caregiver Background Check, National Criminal Background Check, Minnesota Caregiver Background Check (if applicable), and other states if applicable. This is completed in Castlebranch, and the results are uploaded to Student Passport Systems.
